DAMAGE: TOTAL LOSS

I WAS DISPATCHED TO THE SCENE OF AN AIRPLANE CRASH AT GREEN COVE MARINA. I WAS ADVISED THAT THE AIRPLANE HAD STRUCK A HOUSE BOAT. I ARRIVED ON THE SCENE AND FOUND THE HOUSEBOAT FULLY ENGULFED IN FLAMES. NO AIRCRAFT WAS VISIBLE. UNITS FROM THE GREEN COVE FIRE DEPT. AND CLAY COUNTY FIRE RESCUE ARRIVED ON THE SCENE AND BEGAN TO TRY TO EXTINGUISH THE FLAMES.

OFFICER NELSON, KEENER, AND KRAEMER ARRIVED ON THE SCENE AT APPROX. THE SAME TIME AS I DID. WE ALL BEGAN TO CANVASS THE AREA FOR WITNESSES AND TO CONTROL ENTRY TO THE AREA. WE ATTEMPTED TO CONFIRM THAT THE HOUSEBOAT WAS UNOCCUPIED BUT CONFIRMATION WAS NOT OBTAINED UNTIL LATER. CLAY COUNTY SHERIFFS DEPT. PERSONNEL ARRIVED ON THE SCENE AND PROVIDED ASSISTANCE IN CONTROLING TRAFFIC FLOW INTO THE MARINA AND IN PHOTOGRAPHING THE SCENE.

NUMEROUS OTHER AGENCIES WERE EITHER CALLED FOR ASSISTANCE OR PROVIDED ASSISTANCE WITHOUT BEING REQUESTED. THE AGENCIES INCLUDED U.S. COAST GUARD, FLORIDA MARINE PATROL, FLORIDA GAME AND FISH COMM., MEDICAL EXAMINERS OFFICE, FLORIDA DEPT. OF LAW ENFORCEMENT, ST. JOHNS FIRE DEPT., F.A.A., AND N.T.S.B.. A COMPLETE LIST OF ALL PERSONNEL WILL BE COMPILED AND SUPPLEMENTED AT A LATER DATE.

A TOTAL OF 17 WITNESSES WERE LOCATED AND A WRITTEN STATEMENT WAS OBTAINED FROM MOST OF THEM. WITNESS ACCOUNTS AGREED THAT THE PLANE CAME FROM THE AREA OF REYNOLDS PARK, WAS FLYING LOW WHEN THE ENGINE EITHER QUIT OR LOST POWER. THE PLANE TURNED SHARPLY IN A WESTERLY DIRECTION, LOST ALTITUDE RAPIDLY AND STRUCK THE HOUSEBOAT. THERE WAS AN EXPLOSION ON IMPACT AND THE HOUSE BOAT WAS IMMEDIATELY ENGULFED IN FLAMES. WITNESSES WILLIAM AND MARY CALHOUN REPORTED SEEING AN AIRCRAFT DOING "TOUCH & GOES" AT REYNOLDS PARK AND THEN TAKE OFF IN A NORTH EASTERLY DIRECTION. THEY STATED THE AIRCRAFT WAS FLYING LOW BANKED TO THE LEFT AND WENT DOWN. THE AIRCRAFT WAS DESCRIBED BY SEVERAL WITNESSES AS A PIPER CUB TYPE AIRCRAFT WITH EXTREMLY LONG WINGS. THE PLANE WAS ALSO DESCRIBED AS A GLIDER WITH AN ENGINE. MR. TOMAN, CHIEF OF ADMINISTRATION OF PEGASUS TECH. LATER CONFIRMED THAT THE PLANE WAS BEING OPERATED BY PEGASUS PILOTS. HE PROVIDED PILOT INFORMATION AND DIAGRAMS OF THE PLANE.

CHIEF RUSSELL ARRIVED ON THE SCENE AND TOOK COMMAND OF THE SCENE ALONG WITH FIRE CHIEF KNOFF AND FIRE CHIEF CASEY.

THE OWNER OF THE HOUSEBOAT, MR. PETERS ARRIVED ON THE SCENE AND SAID THE BOAT WAS UNOCCUPIED. HE SAID NO ONE HAD BEEN ON THE BOAT FOR APPROX. TWO WEEKS.

THE SCENE WAS PHOTOGRAPHED BY PERSONNEL FROM THE FLORIDA DEPT. OF LAW ENFORCEMENT, CLAY COUNTY SHERIFFS DEPT. AND GREEN COVE POLICE DEPARTMENT. FLORIDA MARINE PATROL PROVIDED A HELICOPTER AND PILOT AND OFFICER KEENER TOOK AERIAL PHOTOS OF THE SCENE.

THE FIRE ON THE BOAT WAS EXTINGUISHED AFTER SEVERAL HOURS AND TWO BODIES WERE LOCATED ON THE BOAT. THE BODIES ARE BELIEVED TO BE THE ABOVE LISTED TWO PILOTS. THE BODIES WERE BURNED BEYOND RECOGNITION AND CAN NOT BE POSITIVLY IDENTIFIED UNTIL DENTAL RECORDS CAN BE OBTAINED. THE BODIES WERE PROCESSED BY CHIEF INV. LOU ELIOPOLUS OF THE MEDICAL EXAMINER'S OFFICE. THE BODIES WERE TRANSPORTED TO THE DUVAL MEDICAL EXAMINERS OFFICE BY CLAY FUNERAL HOME.

ALL STATEMENTS COLLECTED, A COPY OF THE PLANE DIAGRAMS AND ALL FAXES SENT CONCERNING THE INCIDENT WILL BE SUBMITTED TO BE ATTACHED TO THIS REPORT.

CHIEF RUSSEL DIRECTED ME TO INTERVIEW SOME POSSIBLE WITNESSES TO THE PLANE CRASH THAT HAD NOT BEEN PREVIOUSLY INTERVIEWED. HE PROVIDED ME A LIST OF POSSIBLE WITNESSES. ALL BUT FOUR OF THE NAMES ON THE LIST HAD ALREADY BEEN INTERVIEWED. HE ALSO ASKED ME TO REINTERVIEW THE OTHER WITNESSES AND QUESTION THEM ABOUT ANY ENGINE SOUNDS THEY MAY HAVE HEARD FROM THE AIRPLANE PRIOR TO IMPACT. HE EXPLAINED THAT IF ANYONE HEARD A BACKFIRE OR SAW UNUSUAL SMOKE FROM THE ENGINE IT COULD HELP INVESTIGATORS DECIDE WHAT HAPPENED TO THE ENGINE PRIOR TO THE CRASH.

ON TUESDAY, 02/24/98 I WENT THE MARINA AND MADE CONTACT WITH THE BELOW LISTED WITNESSES.

JERRY EVERS, (18), SAID HE WAS STANDING BETWEEN HIS BOAT AND A NINE FOOT HIGH CONTAINER WHEN HE HEARD A LOUD FAN NOISE. HE LOOKED UP AND SAW A PLANE COMING AT HIM. HE STARTED TO RUN, THEN SAW THE PLANE ROLL OVER NOSE DOWN AND CRASH. HE COULD NOT SEE THE IMPACT BECAUSE OF THE CONTAINER BLOCKING HIS VIEW. HE RAN TO THE END OF THE CONTAINER AND SAW THE HOUSE BOAT ABLAZE. HE COULD NOT SEE THE AIRPLANE. HE DID NOT SEE ANY SMOKE OR BACKFIRE FROM THE PLANE PRIOR TO IMPACT.

PHILLIP GOODWIN, (19), SAID HE WAS TALKING WITH EVERS WITH HIS BACK TO THE RIVER WHEN HE NOTICED EVERS' EYES GET BIG AND EVERS SAID "OH NO". HE HEARD THE EXPLOSION AND RAN TO LOOK AT THE HOUSEBOAT. HE DID NOT FIND OUT A PLANE HAD CRASHED INTO THE BOAT UNTIL LATER.

HANS IWAN, (20). SAID HE WAS WORKING ON THE TOP OF HIS DRYDOCKED BOAT, WHICH IS PARKED WEST OF THE MARINA OFFICE. HE HEARD UNUSUALLY LOUD ENGINE NOISE, LOOKED AND SAW A LOW FLYING AIRPLANE FLYING ABOVE THE TREES. THE NOISE STOPPED THE PLANE TRIED TO TURN AROUND, WENT DOWN AND STRUCK THE HOUSE BOAT. HE SAW NO SMOKE AND HEARD NO BACKFIRE.

DAVID HARKENSON, (21), SAID HE WAS NEAR THE TOOL SHED AT THE SOUTHEAST END OF PIER 11. HE SAID HE SAW THE PLANE AND LOOKED AWAY. HE HEARD THE PITCH OF THE MOTOR CHANGE. HE LOOKED BACK UP AND SAW THE PLANE START TO CIRCLE BACK. THE PLANE DOVE INTO THE BOAT AND SECONDS AFTER IMPACT THE HOUSE BOAT WAS ENGULFED.

GERALD ZOLCIAK, (22), SAID HE WAS STANDING IN THE REAR OF THE GREAT LAKES DREDGING WAREHOUSE WHEN HE HEARD A POPPING SOUND. HE TURNED AND SAW A PLANE STARTING TO TURN. THE PLANE'S MOTOR STOPPED AND HE WENT INTO A DIVE AND CRASHED.

I ALSO REINTERVIEWED ALL AVAILABLE WITNESSES. FOLLOWING ARE WITNESSES WHO PROVIDED STATEMENTS WITH ADDITIONAL INFORMATION.

RICHARD SLEAP, (3), SAID HE WAS BEHIND GREAT LAKES DREDGING WHEN HE SAW A PLANE FLYING 200 TO 300 FT. HIGH, FLYING SLOW. HE HEARD A POP OR BACKFIRE AND SAW THE PLANE MAKE A SHARP LEFT BANK ABD CRASH.

ROBERT COX. (5), SAID HE WAS STANDING ON A BARGE GANGPLANK AT THE SOUTH WEST END OF PIER 9. HE WAS WAITING ON A CO-WORKER AND HE WAS FACING EAST. HE SAW THE PLANE CLEAR THE TREE LINE. HE HEARD ONE BACKFIRE AND SAW A TRAIL OF BLUE SMOKE, THE PLANE TURNED TOWARD HIM AND WENT INTO A SPIN AND STRUCK THE HOUSE BOAT.

I ALSO SPOKE WITH LAWRENCE DALES, (9), AND HE SHOWED ME THE VANTAGE POINT FROM WHICH HE WITNESSED THE CRASH. HE WAS STANDING ON THE WALKWAY OF A TWO STORY BUILDING ON THE NORTHWEST EDGE OF MOBRO MARINE PROPERTY. HE ALSO SAID THAT HE UNDERSTOOD THAT MR. HALL, (2), WAS STANDING OUTSIDE THE OFFICE AT THE TIME OF THE CRASH. MR. HALL WAS UNAVAILABLE TO REINTERVIEW AT THAT TIME.

I THEN SPOKE WITH WALLACE FRAZIER, (10), AT RED BAY MARINE. HE SAID HE WAS ALMOST DIRECTLY UNDER THE FLIGHT PATH AND HEARD NO BACKFIRE AND SAW NO SMOKE. HE SAID HE WAS UNABLE TO GIVE A WRITTEN STATEMENT BUT WOULD PROVIDE A VERBAL STATEMENT THAT I COULD TAPE. I AGREED TO MAKE CONTACT WITH HIM LATER AND TAPE HIS STATEMENT.

I MADE CONTACT WITH EDDIE STEWART AT THE REYNOLDS PARK OFFICE. HE PROVIDED ME WITH SEVERL COPIES OF A BLOWN UP MAP OF THE PIER AREA OF THE PARK, I IDENTIFIED THE POSITION OF MOST OF THE WITNESSES AND ANNOTATED THEIR LOCATIONS ON THE MAP.

I RECONTACTED MR. FRAZIER ON 02/27/98, AND TAPED HIS STATEMENT. THE STATEMENT HAS BEEN TYPED AND SIGNED BY MR. FRAZIER.



On 2-21-98 I received a dental cast from Chief Russell which was obtained from the home of Mr. Burns. I transported the cast to the Medical Examiner's Office. Dr. Burns was unable to make an identification of Mr. Burns with the cast.

From Mr. Toman I learned that Mr. Burns dentist was Dr. Arias in Orange Park. I contacted Dr. Arias by telephone and later met with him at his office where I received Mr. Burns dental charts and radiographs. These were taken to the Medical Examiner's Office on 2-22-98.

Dr. Burns was able to make a positive identification of one of the two bodies as that of Mr. Burns.

Dental records of Goffena were received by the Medical Examiner's Office from the U.S. Army and Dr. Burns was able to positively identify Mr. Goffena.

Copies of the photographs were provided to Ralph Wilson of N.T.S.B. The negatives and a set of prints were placed into evidence.
